GENERAL TERMS AND CONDITIONS

Agreement Scope: This agreement grants rights and identifies obligations for the sole purposes of promoting and sharing of the contents of the Talent's presentation at Sponsor's event(s) to occur on or about the dates set forth in the Agreement.

Limited Rights Granted: The Parties understand and agree that unless otherwise agreed, Talent reserves all intellectual property rights in and to her presentation. Talent does however, hereby grant to Sponsor the non-exclusive, perpetual, royalty-free license to permit the Sponsor to use Talent's name, portrait, picture, voice, image, biographical information, current or previous employer's corporate names, quotes, photographs, permitted audio and/or video recordings sponsor has taken of me in connection with my presentation at the Event (my "Likeness"), in whole or in part, without territorial, temporal, or any other limitations, and without compensation to me or further authorization from me, including but not limited to uses made in association with Sponsor's products or services, promotional materials, commercials, marketing campaigns, conferences and online events, trainings, books, websites, social media, annual reports, and any other uses or materials (the "Materials"). Except for the License granted hereby, I retain all rights to my Likeness. Sponsor agrees that all Materials need to be submitted to me for prior approval. Upon request, Sponsor shall provide me with a reasonable number of copies free of charge, of all Materials containing my Likeness for my own use and not for resale or commercial distribution.

Representations and Warranties.

Talent represents and warrants that: (i) I am over the age of eighteen years; (ii) all statements made by me in association with this Agreement are true and accurate as of the date of the Event; (iii) to the best of my knowledge, the consent of no other persons, corporation or organization other than Inspired is required to enable Sponsor to use the rights granted herein; (iv) the rights granted herein do not violate any third party's proprietary or intellectual property rights; and (iv) I fully understand the contents of this Agreement and I intend to be legally bound hereby.

INDEMNIFICATION.

SPONSOR HEREBY RELEASES, INDEMNIFIES, DISCHARGES UNCONDITIONALLY AND AGREES TO HOLD TALENT AND INSPIRED HARMLESS FROM ANY CLAIMS, LIABILITY, DEMAND, DAMAGES AND ACTIONS IN CONNECTION WITH THE EVENT.

Miscellaneous.

This Agreement constitutes the entire agreement of the Parties and supersedes any prior or contemporaneous oral or written understanding as to the subject matter hereof. This Agreement may be signed in any number of counterparts and once signed by all Parties constitute one and the same Agreement, If any part of this Agreement shall be adjudged by any court to be invalid, illegal or unenforceable, the validity, legality, and enforceability of the remaining provisions shall not be affected or impaired. This Agreement shall be governed by and construed in accordance with the laws of the State of Maryland, without regard to conflict of law principles. The parties agree to the exclusive jurisdiction and venue of the Circuit Court for Montgomery County, Maryland. No changes, modifications or waivers may be made to this Agreement unless in writing and signed by all Parties. The failure of any party to enforce its rights under this Agreement at any time for any period will not be construed as a waiver of such rights. In the event that Inspired or Talent are required to utilize an attorney to interpret or enforce this Agreement, whether or not a lawsuit is filed, Sponsor agrees to reimburse Inspired and or Talent for the court costs and attorneys fees.
